1. Purpose of the Tender

The Minister Delegate at the Presidency in charge of Procurements launches an international invitation for tender to be opened in emergency procedure for the supply and turnkey installation of two lots of equipments for an instrumental classification laboratory of cotton fiber for SODECOTON.

2. Scope of the tender

The procurements of this tender consist of three (03) separate lots presented as follows:

Lot 1: supply and turnkey installation of instrumental classification laboratory of cotton fiber.

The provision and turnkey installation of the above referenced Lot 1 will be imperatively associated with the services listed below:

- Training of both the Operator and maintenance agent for the use and maintenance of the fiber measurements equipment for at least one month;
- Providing a list of spare parts and accessories;
- Providing the first kit of spare parts and accessories required for the first year of operation of the devices;

• Providing a technical description including (1) the required mass per sample, (2) the time required for a complete analysis, (3) the principle of measurement of each characteristic of the fiber.

Lot 2: Supply and turnkey assembly of a cell with modular panels, an air conditioning system and a quick conditioning system of the test samples.

3. Participation

Participation in this tender is limited to all industrial equipment suppliers based in Cameroon or in a member country of the Islamic Development Bank (IDB).

4. Financing

Funding will be provided by the Islamic Development Bank as part of the Integrated Development Project of Cotton and subsistence crops (PDICV) for the amount excluding VAT part and the State of Cameroon for the VAT part.

5. Consultation and withdrawal of the tender dossier

The Bidding Documents may be consulted during working hours at the Ministry of Public Procurement, within the Special Support Unit for the Launch of Tenders (CALAO), located in the building housing its services, Building A, door R09 of the 1st floor on publication of this notice.

The tender document shall be removed on presentation of a receipt of payment to the Public Treasury of a non-refundable sum of four hundred thousand (400 000) CFA francs

This release must identify the payer as agent for the supplier willing to participate in the tender.

6. Estimate

The estimated cost of the operation at the end of preliminary studies is: one billion five hundred and sixty million (1 560 000 000) CFA Francs.

7. Submission of tenders

Each offer, drafted in French or in English in seven (07) copies, one (01) original and six (06) copies labeled as such, must be received in sealed envelopes, to the Special Support Unit for the launch of tenders (CALAO) of the Ministry of Public Procurement, located in the building housing the Services of the Ministry of Public Procurement, building A 1st floor, door R09 **no later than _16/08/2016 to _10 hours and** deposited against a receipt. It should be marked:

8. Admissibility of offers

Each bidder must include in his administrative documents a bank guarantee valid bid for one hundred twenty (120) days in the amount of:

- Lot 1: 19,900,000 (nineteen million nine hundred thousand) CFA francs,
- Lot 2: 9,800,000 (nine million eight hundred thousand) CFA francs,
- Lot 3: 1,500,000 (one million five hundred thousand) CFA francs,

or their equivalent in the tender currency issued by a bank listed among valid banking institutions or licensed financial organizations approved by the Ministry of Finance to issue bonds in the context of public procurement in accordance with the code of Public Procurement. The list of these banks is appended to this file. Foreign banks will issue bid bonds as part of this tender, will have correspondents in the network of local first rated banks.

The absence of the original bid bond copy, the insufficiency of the amount of the bond or non-compliance with the model will result in the outright rejection of the offer without any recourse.

9. Bid Opening

The opening of bids will take place in one session and will take place on _16/08/2016 from 11 hours local time, by the Central Commission for Procurement of General Procurement UNIT, 2nd floor of Building B next to the MINMAP DJEUGA PALACE Hotel, opposite CAMEROON INSURANCE.

Bidders attending the opening session or represented by a duly authorized agent having perfect knowledge of the case. One representative per tenderer will be admitted in the room.

10. Evaluation Criteria

For the final comparison of bids, the following criteria will be considered:

10.1 Eliminatory Criteria:

Criterion A: In case of Absence or non-compliance of any document of the administrative file, beyond a 48 hours delay given to bidders who produced the non-conformed file;

Criterion B: falsified documents or forged declaration;

Criterion C: Absence of the bid bond;

- **Criterion D:** Absence of the after sells service: availability (i) of a local representation in one of the three northern Region of Cameroon, (ii) a dedicated technician living in one of the three northern region of Cameroon, and (iii) gage of the availability of the standard replacement part standard (full listing);
- **Criterion E:** Non-compliance with the technical characteristics of the supplies descriptive (100%);

Criterion F: Non-compliance with the delivery term (≤ 120 days);

Criterion G: No membership in IDB member countries (patent);

Criterion H: No Satisfaction 3 of 4 essential criteria;

Criterion I: Lack of any quantified Unit Price;

Criterion J: absence of Manufacturer authorization or the distributor agreement delivered by the manufacturer;

Criterion K: Absence manufacturer leaflet and the technical slip.

10.2 Essential criteria:

- **Criterion A: tenderer's references:** to justify of at least one delivery of similar supplies during the last 05 years (minutes of the reception, first and last pages of the contact);
- **Criterion B:** market acceptance condition (CCAP and CCTP initialed and signed at the last page);

Criterion C: the average Turnover for the last five years:

- Lot 1 ≥ 1,000,000,000 (One Billion) CFAF ;
- Lot $2 \ge 500,000,000$ (Five hundred million) CFAF ;
- Lot 3 ≥ 100,000,000 (One Hundred Million) CFAF ;

Criterion D: Presentation of the Offer (separating different sections with dividers in color, room layout in order);

The assessment of these criteria will be purely positive or negative way. Any negative response (no) when reviewing the Eliminatory criteria will result in disqualification of the offer. As the essential criteria, a minimum of three (03) of 4 positive responses in total will be required to be retained.

11. Price Evaluation

Only the price offers of the bidders that were technically qualified will be considered for further analysis.

12. Award of contract

After the evaluation of tenders, the contract will be awarded to the bidder whose bid has met the qualification criteria and whose bid is the lowest evaluated bidder.

13. Duration and validity of bids

It is specified that bidders will remain committed by their offers for a period of one hundred twenty days (120) days from the deadline for submission of bids.
