To set thresholds and types of contracts that may be awarded online for the 2021 financial year.

Mindful of Decree No. 2018/0001/PM of 5 January 2018 to set up a public contracts dematerialization platform and to lay down rules for its use;

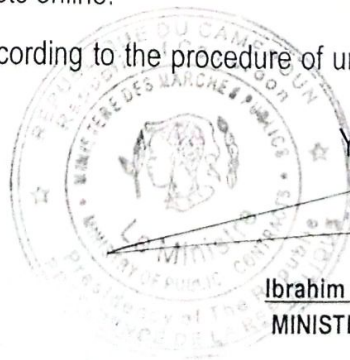
Mindful of Decree No. 2018/0002/PM of 5 January 2018 to lay down the terms and conditions for the online award of public contracts in Cameroon;

Mindful of Decree No. 2018/366 of 20 June 2018 to institute the Public Contracts Code;

Mindful of Decree No. 2019/002 of 4 January 2019 to reshuffle the Government;

**HEREBY ORDERS AS FOLLOWS:****Article 1.-** This order sets thresholds and types of contracts that may be awarded online for the 2021 financial year:**Article 2.-** The thresholds and types of contracts that may be awarded online for the 2021 financial year are as follows:

- at least equal to 300.000.000 (Three Hundred Million) CFA francs for roads;
- at least equal to 150.000.000 (One Hundred and Fifty Million) CFA francs for other infrastructures;
- at least equal to 75.000.000 (Seventy-Five Million) CFA francs for Buildings and Community Facility Works;
- at least equal to 30.000.000 (Thirty Million) CFA francs for general procurement;
- at least equal to 30.000.000 (Thirty Million) CFA francs for intellectual and other services;

**Article 3:** The Project Owners designated the pilot phase of the operationalization of the dematerialization platform should award at least 40% (Forty percent) of their projects online.**Article 4.-** This order shall be registered, published according to the procedure of urgency and inserted in the Official Gazette in English and French./
