To set the list of instruments and documents that must be published on the public contracts dematerialization platform for the 2021 financial year.

THE MINISTER DELEGATE AT THE PRESIDENCY OF THE REPUBLIC IN CHARGE OF PUBLIC CONTRACTS,

- Mindful of the Constitution;
- Mindful of Law No. 2000/010 of 19 December 2000 governing archives;
- Mindful of Law No. 2010/012 of 21 December 2010 on cyber security and cybercrime in Cameroon;
- Mindful of Law No. 2010/013 of 21 December 2010 governing electronic communications in Cameroon, as amended and supplemented by Law No. 2015/006 of 20 April 2015;
- Mindful of Law No. 2010/021 of 21 December 2010 governing electronic commerce in Cameroon;
- Mindful of Decree No. 2011/408 of 9 December 2011 to organise the Government, as amended and supplemented by Decree No. 2018/190 of 2 March 2018;
- Mindful of Decree No. 2011/410 of 9 December 2011 to form the Government;
- Mindful of Decree No. 2011/412 of 9 December 2011 to reorganise the Presidency of the Republic;
- Mindful of Decree No. 2012/075 of 8 March 2012 to organise the Ministry of Public Contracts;
- Mindful of Decree No. 2018/0001/PM of 5 January 2018 to set up a public contracts dematerialization platform and to lay down rules for its use;
- Mindful of Decree No. 2018/0002/PM of 5 January 2018 to lay down the terms and conditions for the online award of public contracts in Cameroon;
- Mindful of Decree No. 2018/366 of 20 June 2018 to institute the Public Contracts Code;
- Mindful of Decree No. 2019/002 of 4 January 2019 to reshuffle the Government;

HEREBY ORDERS AS FOLLOWS:

Article 1.- (1) This order sets the list of instruments and documents that must be published on the public contracts dematerialization platform with regard to the award and execution of public contracts for the 2021 financial year.

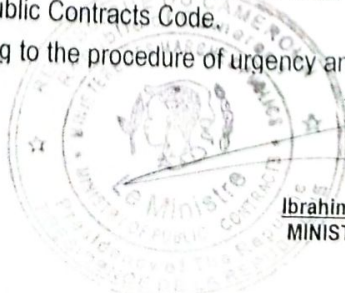
(2) The acts referred to in Article 2 below shall be published on the "Cameroon Online E-procurement System" platform abbreviated "COLEPS".

Article 2.- The list of instruments and documents referred to in Article 1 above shall include:

- Tender Notices, Calls for Expression of Interest and their possible amendments or any public bidding document;
- Tender Files or any consultation file serving that purpose and their possible addenda;
- Award decisions and releases publishing the results;
- Decisions resulting from the petitions review in the public contracts award phase;
- Decisions terminating public contracts;
- Sanctions of exclusion from public procurement.

Article 3.- The publication of the instruments and documents listed in Article 2 above shall be done on the dematerialization platform, without prejudice to the rules of publicity prescribed by the Public Contracts Code.

Article 4.- This Order shall be registered, published according to the procedure of urgency and inserted in the Official Gazette in English and French.
